

INFORMATION NOTICE NR. _____ ON PROCESSING OF PERSONAL DATA PURSUANT TO ARTICLE 13 OF LEGISLATIVE DECREE NO. 196/2003

Pursuant to article 13 of Legislative Decree no. 196/2003 your personal data are collected and processed for any of the following purposes:

- Enable all activities connected with the performance of contracts with clients and/or third parties involved;
- Fulfil laws and regulations such as accounting and fiscal records, anti-money laundering law etc;

Pursuant to article 7 of Legislative Decree no. 196/03, you are entitled to know what data are stored, their source and purposes of the processing, and to ask for their erasure or updating. Furthermore, you are entitled to object, in whole or in part, to illegitimate processing, as well as to the processing of personal data for commercial and advertising purposes.
